Submitted articles will be reviewed. All of the conference partici-pants, whose articles are accepted for the conference, will be sent an e-mail invitation by **April 01, 2024.**

CONFERENCE FEE



INSTRUCTIONS FOR FORMATING AN ARTICLE

The volume of the article is 5 pages of text, including figures, tables, diagrams, list of references, information about the authors.

The main text is set using the Word test editor. A4 format. The font is Times New Roman, 14 points. The line spacing should be 18 points, the number of text lines per page should be 39-40. In the case of insertion into the formula line, an increase in the line spacing is allowed. Para-graph indent - 1.25 cm.

The following margins are set: top and side - at least 25 mm, bottom - 30 mm.

The font should be straight, expressive, black, uniform throughout the text.

It is allowed to use computer capabilities of focusing attention on notation, terms, theorems, important features, using different fonts: italic, bold, italic bold, highlighting with frames, spacing, underlining, etc. Uppercase and lowercase letters, superscripts and subscripts in formulas must be clearly marked. The following sizes of signs for formulas are recommended: uppercase letters and numbers - 7–8 mm, lowercase let-ters - 4 mm, exponents and indices - at least 2 mm.

The article includes the following elements in order: -UDC. Font size 14 p., capital letters, left alignment;

-initials and surname of the author(s). Font size 14 p., lowercase, bold, center alignment, initials are separated by a space;

-the title of the published material. Font size 14 p., lowercase, bold, center alignment;

• annotation. Font size 12 p., italics, justified alignment. Abstract (30-100 words) should clearly state the content of the article;

• main text. Font size 14 p., alignment in width, with the author highlighting the necessary parts of the text in program fonts ("Bold", "Ital-ic");

• tables. For table titles - font size - 14 pt. For table contents - font size 12 pt., light. The size of the table in width should be exactly 110 mm (the table should not take more than 1 page);

• reference bibliographic lists. Font size 14 p., justified alignment. Between the bibliographic list and the main text, the interval is 18 pt.;

• summary. Font size 12 p., italics, justified alignment;

• Information about authors. Font size 12 p., justified alignment. Sur-name, name and patronymic of the authors, supervisor - bold italics. For students (undergraduates, graduate students) it is necessary to indicate the faculty, specialty, educational institution. For their supervisors -position and organization - place of work, academic degree and title (if any).

Articles drawn up in violation of the above rules are not accepted for publication.
